# 11. Word by County Cllr. Gwennol Ellis: County Cllrs report:

Toilets

Meeting of the Finance and Resources Scrutiny Committee 02.09.24 – the Tory party group on the Council has come with a warning that there is not enough consultation before the announcement in July that 19 toilets, including Pentrefoelas to close. Discussion for 2 hours on tis item at the meeting. The Council will face a deficit of £21 million in the 2025-26 budget. It is inevitable that the toilets will close as there is no money to keep them open – almost everyone agreed on that.

The Committee members passed almost unanimously that the closure should be postponed and to give an opportunity to discuss further with Community and Town councils what can be done to keep the toilets open if this is the wish.

A site visit will need to be arranged with Gary Williams, Asset Manager as soon as possible to discuss option sin Pentrefoelas.

Grant:

A message from Elgan Owen – CVSC – many funders would support community and town councils to run these services – although it would be difficult to find long-term funding. We are already having discussions with several town and community councillors regarding this. We would need a 5+ year lease or even asset transfer. Clocaenog, Gwynt y Mor and Rhyl Flats would cover this in some areas of Conwy and the Lottery would be another possible funder.

Waiting for a date that is convenient for the Community Council and officers to meet in Coed Pella. Cllr. Nigel Smith is very keen to discuss the 'Cwmpas' plan with the members to look at options for a group of people to take the land from the Council at a reasonable price and to steer the discussions with the Council If the County Council secured permission for individual plots and sold them separately, the cost would be significantly higher for the buy
